There is a \$100.00 discount for the second student, \$200.00 for the third student and fourth student free, from the same family, living in the same household. The full student rate shall always be charged for the oldest student; the second student rate will be charged for the next oldest student, etc. **ASK about our finders fee for students in grades 1 – 12 and how you can get up to 100% off of one student's tuition!**

PLEASE NOTE: There will be an additional charge of **\$110.00 PER FAMILY** for the building fee. The building fee may be paid on the monthly plan OR in one lump sum. However, if a student is withdrawn, the **balance** of the building fee is **due in full**.

EARLY enrollments receive a reduced registration rate **through April 4th** of **\$60.00** per student.

Registration fee is \$80.00 per student **between April 5th and May 2nd** After May 2nd, registration fee is \$100.00 per student.

Monthly payments are due on the **first** of each month, unless other arrangements have been made with the office. The payments will be considered late if not *received by the 10th* of the month and a **late fee** of **\$30.00** will be added to the account. A statement will be mailed prior to your due date which will include your monthly tuition, building, computer charges, and day care, if applicable. There will be a **\$30.00 per check** fee for all returned checks, for any reason. Students will *not* be allowed to remain in school if tuition payment is over one month past due. If a student attends one day during a month, the tuition is owed for the entire month. A student is enrolled until a parent withdraws him/her according to the handbook. Interest of 1.5% *per month* will be charged on *any* amount 60 days in arrears. Report cards and records will be withheld if payments and fees are not current at the end of each quarter. If collection is necessary, the responsible person(s) would be liable for all collection agency fees (can be up to an additional 50% of the amount turned over for collection) paid or incurred by us. Attorney fees, court costs and other costs paid or incurred are also applicable and the responsibility of the person with the delinquent account. **All records** will be held until balance is paid in full.

To qualify for **K3/K4**, must be 3 years old and potty trained by **Aug. 1**; **K4**, must be 4 years old by **Aug. 1**; for **K5**, must be 5 years old by **Aug. 1**.
